DispatchHealth® offers safe, convenient, and affordable care in your home for urgent health needs that do not require an emergency room (ER) visit if you reside in one of the eligible zip codes. When you can't visit your doctor, you can still get the care you need.



How it works

- Request care: You can check eligibility and request DispatchHealth's services by calling (888) 791-2380, 8 a.m. to 10 p.m., seven days a week, including holidays. You can also visit DispatchHealth.com. No pre-registration is required.
- 2. **Explain your symptoms:** Share a few details about your illness, injury, or other information to the DispatchHealth provider.
- 3. Receive care by a medical team you can trust: DispatchHealth will arrive within a few hours to provide treatment. Each team includes a nurse practitioner or physician assistant, plus a medical technician. An on-call emergency medicine physician is always available by phone for consultations.
- 4. DispatchHealth takes care of the rest: DispatchHealth calls in any prescriptions you might need, updates your doctor, and processes billing.

DispatchHealth treats simple to complex illnesses and minor injuries – all from the comfort of your home. These may include:

- · Severe abdominal pain
- Stroke symptoms (numbness or weakness on one side, difficulty speaking, swallowing, or walking)
- · Vomiting blood
